

### STATISTICS DEPARTMENT MEDIA RELEASE (11<sup>th</sup> of May 2021)

#### Highlights from Foreign Trade Statistics, Quarterly (December 2020)

1. Foreign Trade Statistics for the Fourth Quarter of 2020 recorded a Trade Deficit of T\$ 150.5 million. The deficit was the result of an excess Imports T\$162.7 million over Export (including Re-exports) T\$12.2 million for the period of October to December 2020.
2. When compared with the Trade Deficit of T\$ 123.9 million from the Third Quarter 2020, we find an increased with T\$26.5 million (21.4 %)
3. **Major Commodity Classification**

3.1 Largest in Imports by Harmonized groups was the ***Machinery & mechanical & electrical appliances & parts thereof*** T\$ 36.1 million (22.2 %), second was the ***Prepared foodstuffs, beverages, spirits & tobacco*** T\$ 23.5 million (14.5 %) and the third was ***Mineral products*** with T\$21.4 million (13.2 %). Next group was the ***Live animals: animal products*** T\$17.6 million (10.9). The remaining T\$ 63.8 million (30.7 %) was shared by other groups.

3.2 Exports by Harmonized commodity groups reported the ***Vegetable products*** as the highest group with T\$ 6.7 million (57.6 %) next was the ***Live animals: animal products*** with T\$4.06 million (34.4 %) followed by the ***Prepared foodstuffs, beverages, spirits & tobacco*** T\$ 0.3 million (3.2 %). The remaining T\$0.56 million (4.7 %) was shared by rest of the Harmonized commodity groups.

### **4. Principal Items of Trade;**

4.1 The Principal domestic Exports for this Quarter was **KAVA** which accounted for 31.2 % of total domestic exports, followed by **FISH** at 11.3 % and **ROOT CROPS** with 10.3 %. Together they comprise 52.8 % of domestic exports.

### **5. Direction of Trade;**

5.1 Imports for Quarter December 2020 were mainly from **New Zealand** with T\$49.2 million (30.3%), **Singapore** with T\$ 18.3 million (11.2 %), **China** were T\$14.5 million (8.9 %) and **U.S.A** were T\$13.05 million (8 %), **Australia** with T\$12.1 million (7.5 %) and T\$55.3 million (34 %) shared amongst other countries.

5.2 Exports were mainly to **New Zealand** with T\$ 4.7 million (38.9 %), **Hong Kong** with T\$1.8 million (15.2 %), **U.S.A** with T\$1.6 million (13.5 %), **Korea** with T\$0.9 million (7.9 %) and T\$ 2.9 million (24.4 %) were shared amongst other countries

6. The Statistics presented have been compiled from Import, Export and Re-export entries submitted by Importers and Exporters or their authorized agents to the Customs Division as required by the Customs Act and Regulations.

### POTUNGAUE SITETISITIKA ONGOONGO (‘Aho 11 ‘o ME 2021)

**Ko e ngaahi fika ke fakatokanga’i mei he Lipooti ‘o e Fefakatau’aki ‘a Tonga mo Tu’apule’anga, Kuata Tisema 2020 ‘a e Potungaue Sitetisitika.**

1. Ko e Fefakatau’aki ‘a Tonga mo Tu’apule’anga ki he Kuata ko Tisema 2020, na’e lekooti ai ha fe’amokaki fe’unga mo e T\$150.5 miliona. Ko e fe’amokaki ni ‘oku tupu ia mei he ma’olunga ange ‘a e koloa humai, fe’unga mo e T\$162.7 miliona ‘i he koloa huatu (Fakataha’i mo e koloa Humai pea toe Huatu) ‘a ia ko e T\$12.2 miliona ‘i he Kuata Tisema 2020.
2. ‘I hono fakafehoanaki mo e fe’amokaki ‘o e Kuata kuohili (Kuata Tisema 2020) ‘a ia na’e T\$123.9 miliona, ‘oku ha mai ‘a e Hiki ‘a e fe’amokaki ‘aki ‘a e T\$26.5 miliona ‘a ia ko e peseti ‘e 21.4.
3. **Tefito’i Kulupu Fefakatau’aki;**
  - 3.1 Ko e Kulupu ne lahi taha hono Humai ko e **Misini mo e Naunau Mekēnika** ‘a ia na’e T\$36.1 miliona (22.2 %), hoko hake ko e Koloa **Me’atokoni ‘osi teuteu’I** á ia na’e feúnga moe T\$ 23.5 miliona (14.5%), **Koloa fakanatula (lolo)** naé feúnga ia moe 21.4 miliona (13.2 %), hoko hake á e Koloa **Monumanu Mo’ui mo e Ngaahi Koloa ngaohi mei he me’a mo’ui kau ai ‘a e ika** T\$17.6 miliona (10.9 %). Ko e toenga leva ‘o e Koloá na’e fe’unga mo e T\$63.8 milliona (30.7 %) ‘a ia ne vahevahe ia he toenga ‘o e ngaahi Kulupu kehe.
  - 3.2 ‘I he Koloa Huatu ko e kulupu ne ma’olunga taha hono lekooti ko e **Vesitapolo** ‘a ia ne fe’unga mo e T\$6.7 miliona (57.6%), ne hoko hake leva ‘a e Kulupu ki he **Monumanu Mo’ui mo e Ngaahi Koloa ngaohi mei he me’a mo’ui kau ai ‘a e ika** ‘a ia ne T\$4.06 milliona (34.4 %), hoko hake ki ai e ngaahi **Koloa Meatokoni, Kavamalohi & Tapaka** ‘a ia na’e fe’unga mo e T\$ 0.3 miliona (3.2 %). Ko e 0.56 miliona (4.7 %) ne vahevahe ia he toenga ‘o e ngaahi Kulupu kehe.

#### **4. Tefito'i Koloa 'o e Fefakatau'aki.**

Ko e koloa ne lahi taha hono huatu 'i he Kuata Tisema 2020 ko e **Kava** ne fe'unga mo e peseti 'e 31.2 %, hoko hake ki ai ko e **Ika** ne fe'unga ia mo e peseti 'e 11.3 %, pea hoko hake **Ngoue Foha** ne fe'unga mo e 10.3 % peseti. Katoa e ngaahi koloa ne lahi taha hono huatu ki tu'apule'anga na'e fe'unga mo e peseti 'e 52.8

#### **5. Tefito'i Hoa Fefakatau'aki**

5.1 Ko e Koloa Humai ki he Kuata ko Tisema 2020 ne lahi taha hono humai mei **Nu'usila** 'a ia ko e T\$49.2 miliona (30.3 %), **Singapoa** ko e T\$18.3 miliona (11.2 %), **Siaina** ko e T\$ 14.5 miliona (8.9 %), **Amelika** ko e T\$13.05 miliona (8 %), **Aositelelia** ko e T\$12.1 miliona (7.5 %), pea ko e T\$55.3 miliona (34 %) ne vahevahe ia he toenga 'o e ngaahi Fonua kehe.

5.2 'I he Koloa Huatu ne lahi taha pe e koloa ne huatu ki **Nuúsila** 'a ia ko e T\$4.7 miliona (38.9 %), **Hong Kong** ko e T\$1.8 miliona (15.2 %), **Amelika** ko e T\$1.6 miliona (13.5 %), **Kolea** ko e T\$0.9 miliona (7.9 %), pea ko e T\$2.9 miliona (24.4 %) ne vahevahe he toenga 'o e ngaahi fonua kehe.

6. Ko e ngaahi Fika Sitetisitika ko 'eni na'e tanaki ia mei he Lekooti 'o e Ngaahi Koloa Humai mo Huatu kotoa pe, 'a ia 'oku tanaki 'e he va'a Kasitomu 'o fakatatau ki he Lao 'o e Kasitomu.
7. Fakaikiiki fekau'aki mo e fakamatala ni 'e malava ke ke ma'u ia mei he Potungaue Sitetisitika, Tonga, TMF Building, Hala Taufa'ahau, Nuku'alofa.
