Introduction

Survey Objective

This is the sixth bulletin on Manufacturing Output, Employment and Wages and Salaries for the fiscal year 2021/2022. This report presents the results of the quarterly survey of manufacturing production, employment and wages/salaries, conducted by the Statistics Department of Tonga for the period of 2021/22. The main objectives of the survey are:

- To provide updated information on levels of production, employment and wages/salaries.
- To provide some data for the components of National accounts.
- To provide information on the performance of manufacturing industries for planners, policy makers and the general public.

Coverage

The Department launched a regular quarterly survey of Manufacturing Production, Employment and Wages and Salaries effective from financial year 1983. The survey covered all manufacturing establishments and units that were registered as manufacturing type,

- a. under the Companies Act 1912,
- b. those who were granted Development License for manufacturing under the Industrial Incentives Act 1978, and
- c. those engaged in manufacturing activities with a license issued by the Ministry of Trade, and Economic Development.

The survey did not cover enterprises, establishments and units that were engaged in

- a) repair and maintenance of vehicles, machinery, and equipment,
- b) canning, preserving, and processing of fish and fisheries products, and
- c) household type of activities related to making handicrafts and the like.

An establishment was treated as manufacturing if it was engaged in the transformation (mechanical or chemical) of substances into new products whether by machines or by hand in a factory or other business premises. An establishment/unit engaged in the assembly of component parts of manufactured products was treated as engaged in manufacturing except where it undertook construction activity.

However, the definitions used for manufacturing businesses for the survey in question were: **Enterprises**: A single business entity, Private, Government, Quasi-government and Cooperative operating in Tonga as a legally constituted body such as a company, partnership, co-operative and sole ownership, engaged in manufacturing type of activities is treated as an enterprise. There are generally two types of enterprises viz.:

- i. "Single Establishment Enterprise" consisting of only one establishment and
- ii. "Multiple Establishments Enterprise" consisting of more than one establishment with or without an ancillary unit or one establishment plus one or more ancillary units.

Establishment: a separate operating unit (factory, store, workshop, or other place, etc.) engaged in Tonga in one or predominantly one kind of economic activity at a single physical location.

Response rate

The response rate was 81%. The total number of manufacturing businesses was 106, out of which 86 responded to the survey.

Data Collection

Data collection was done in person by the survey staff of the Statistics Department of Tonga to the manufacturing enterprises, establishments and units that were operational in the various quarters starting from July 2021 to July 2022. This covers establishments on the four main island divisions of Tonga namely Tongatapu, Vava'u, Ha'apai and 'Eua.

Data Processing

Data entry and preparation of the final tables was done using Microsoft Office Excel. Manufacturing establishments have been classified into Divisions according to the International Standard Industrial Classification (ISIC) Series M No. 4, Rev. 4 for Major Divisions 10 - 33, Manufacturing Industries

Estimation

This report includes figures that were estimated because of unreported figures for some of the businesses quarters and a low response rate from

- Island Division of 'Eua
- Institutional sector of government and quasi-government.

The method of estimation, a rate is calculated from the each of the ISIC Division level and used to increase or decrease (given that if it is an increasing/decreasing rate) available quarters to estimate the previous or prior missing quarter figures. If no information has been collected for it from a particular sector, the last quarter of this sector from the last report, is then divided amongst the sample size, before the rate is used for calculation.

Summary of Survey Results

There were 106 manufacturing businesses in the survey with a production of T\$46.5 million. A total of 658 persons were employed in manufacturing which comprises T\$8.4 million in wages and salaries for 2021/21.

below gives a summary of the survey. From the summary table below, it can be observed that the components measured (total production, persons employed, wages and salaries), has all decreased from the previous financial year 2020/21 to 2021/22. Total production has decreased by 23.5%, persons employed by 8.4%, wages and salaries by 69.7%.

Manufacturing Output

The manufacturing output refers to the value of products produced during the period of 2021/2022 in monetary terms. It will be given in terms of its share by ISIC Division, Island Division and Institutional Sector. *Table 2* below shows the total value of manufacturing output at end of 2021/22 which was T\$13.8 million. Out of which Food Products held the biggest share 29.8%, Manufacture of other non-metallic mineral products followed by T\$8.6 million (18.4%), Manufacture of fabricated metal products, except machinery and equipment T\$6.8 million (14.8%) followed by Manufacture of tobacco products T\$4.6 million (10%), Manufacture of beverages T\$3.6 million (7.8%). These were the top five industries that contributed the most to the manufacturing sector. Some examples of business that fall under each ISIC Division mentioned above are, A. Cowley and Sons (Food Products), Luna'eva Quarry (Non-metallic minerals), Rotomould (Pacific) Ltd (Fabricated Metal), International Metropole Corporation Ltd (Tobacco products), Rod King Distillers (Beverages).

Table 3 shows that Tongatapu dominated the production in 2021/22 financial year by T\$42.8 million (92.0%). And the other islands namely, Vava'u contributed T\$2.2 million (4.7%), Ha'apai contributed T\$1.2 million (2.6%) and 'Eua divisions contributed the remaining T\$0.3 million (0.6%).

The Island Division of Tonga had a production level decrease for each of the Islands from the financial year 2020/21 to 2021/22. Tongatapu's production level decreased by 19.7%, Vava'u with 47.6%, Ha'apai with 51.3% and 'Eua with 63.9%. The significant decrease in the production level seen year-on-year could be attributed to the Hunga Tonga-Hunga Ha'apai eruption and tsunami. As reported in the Impact report submitted by FAO in November 2022, the volcanic ash resulted in damage and loss in the fisheries and aquaculture sector. ¹

The contribution by Institutional Sector to Manufacturing Output given in *Table 4* hereunder, states that the Private Sector contributed T\$43.9 million (94.4%) in 2021/22. The rest was contributed by Government and Quasi-Government Sector with T\$2.6 million (5.6%) for 2021/22.

The Institutional Sector of Tonga had a production level decrease for each of the sector from 2020/21 to 2021/22. The Private sector's production level decreased by 19.3%, and the government and quasi-government sector 59.5%.

Manufacturing Employment

The level of employment carried by each industrial division at end of 2021/22 is shown below. In Table 5, the share of employment in 2021/22 was led by Manufacture of Food with 168 employees (25.5%), followed by Manufacture of other non-metallic mineral products with 153 employees (23.2%), Printing and reproduction of recorded media with 86 employees (13.1%), Manufacture of beverages with 66 employees (10.0%), Manufacture of wood and products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials with 46 employees (7.0%).

In *Table 6*, we see the employment level by Island Division. Tongatapu division employed 559 in 2021/22 of the total people employed (84.9%), Vava'u division employed 74 (11.2%), Ha'apai division employed 14 (2.1%) and 'Eua divisions employed 12 (1.8%) of the total people employed.

The employment level for island division of Tonga has decreased from the financial year 2020/21 to 2021/22, except for Vava'u. Tongatapu's employment level decreased by 6.1%, Ha'apai decreased by 65.9%, and 'Eua decreased by 7.7%. Whereas Vava'u's employment level increased by 8.8%.

The Employment position at the Sectoral level (Table 7) indicates that the Private Sector had a workforce of 603 persons (91.7%), while the Government and Quasi-Government Sectors employed 55 persons (8.3%) in 2021/22.

For each of the institutional sector, the employment level had decreased. The private sector decreased by 1.8%, while the government and Quasi-government sector decreased by 47.1%.

Manufacturing Wages/Salaries

Table 8 shows the share of wages and salaries paid to employment carried by various divisions at end of 2021/22. Of these, Manufacture of other non-metallic mineral products took the highest share of payments with T\$2.0 million (23.6%), followed by Printing and reproduction of recorded media with T\$2.0 million (22.8%), followed by Manufacture of food products with T\$1.8 million (21.3%), followed by Manufacture of beverages with T\$0.8 million (9.6%), followed by Manufacture of wood and products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials with T\$0.5 million (6.5%).

By Island Division in *Table 9* for 2021/22, Tongatapu paid the highest share of wages and salaries to the amount of T\$7.6 million (90.5%), Vava'u division paid T\$0.3 million (4.3%), Ha'apai division paid \$0.3 million (3.4%) and 'Eua divisions paid \$0.2 million (1.8%). The wages and salaries for the Island Division have had some major decreases between the financial year 2020/21 to 2021/22. For Tongatapu, wages and salaries decreased by 67%, for Vava'u by 86.2%, for Ha'apai by 81.8% and 'Eua by 70%.

The contribution by Institutional Sector to wages and salaries was noted as given in *Table* 10 hereunder; it can be seen that the Government and Quasi-Government Sectors contributed T\$1.2 million (14.7%) and Private Sector T\$7.2 million (85.3%) in 2021/22.

The wages and salaries for Institutional Sector had decreased in the financial year 2021/22 from 2020/21. The private sector decreased by 70.4%, and the government and quasi-government sector decreased by 65.3%.

Appendix 2

INSTRUCTIONS FOR COMPLETING THE QUESTIONNAIRE ON QUARTERLY SURVEY OF MANUFACTURING PRODUCTION, EMPLOYMENT AND WAGES/SALARIES.

1. GENERAL

Please note that the code number on the right-hand corner of the questionnaire is your establishment's code number based on the Register of Establishments maintained in the Statistics Department. The information, being requested should relate only to the quarter referred to in the questionnaire.

2. PRODUCTION

- 2.1 Please enter all the products produced by the establishment and for each such product please:
 - i) Specify the unit used for measuring each product (e.g., kg, dozen, liter etc.)
 - ii) Enter the average quantity, in the unit stated in (I) above, of the products produced during each month of the reference quarter.
 - iii) Enter the average ex-factory value of the quantity referred to in (II) above.
- 2.2 Enter here the total value of the products other than the main ones mentioned in 2.1 manufactured by the establishment.
- 2.3 Enter here the total value of work done by your establishment for others.

3. EMPLOYMENT AND WAGES/SALARIES

For each category of employees (at 3.1 a to d) please: -

- Enter in the column "No" either column 2,5 and 8 the total number of persons engaged in the establishment on the last payday of each month of the reference quarter. The family workers working on the last payday should be entered though they may not be paid.
- ii) Enter in column "Wages/Salaries Paid" either column 3, 6 and 9 the total amount of wages and salaries paid to employees by cash/cheque as compensation for the services rendered by them. This should include all payments made on account of bonuses, cost of living allowances and wages paid during vacation and sick leave for the reference period. Payments made to (1) regular/full-time and (2) part-time/casual and daily paid workers should be shown separately.

3.1 Category of Employees: -

- a) Working proprietors and active partners: are all individual proprietors and partners who are
 actively engaged in the work of the establishment.
- b) <u>Production workers</u>: are those who are directly engaged for pay in the production activities of the establishment. They may be full-time/regular or part-time/casual/daily paid.
- c) <u>Unpaid family workers</u>: refers to all such family members working in the establishment without regular pay at least one-third of the normal working time.
- d) other employees: refers to all persons other than those listed above working in the establishment. This shall include administrative, technical and clerical personnel such as salaried Managers, Directors, Clerks, Typist, Bookkeepers, Administrative Supervisors, Salesmen, etc. Proprietors and partners shall be excluded in here but included under 3.1(a) above.
- 3.2 <u>Memorandum items</u>: (wages and salaries paid in kind) refers to the net cost to the employer, of those goods and services provided to employees free of charge or at a markedly reduced cost which are clearly of benefit to employees. The items included normally are food, beverages, tobacco, clothing etc. Note that an estimated value of these items will be acceptable.

- 2.2 Fakafonu mai e mahu'inga fakakatoa e ngaahi koloa na'e ngaohi kehe mei he koloa 'oku ha 'i he 2.1.
- 2.3 Fakafonu e mahu'inga fakakatoa e pa'anga na'e ma'u mai 'i ha ngaue kehe na'e fai 'i he ngaue'anga (hange ko e ngaue konituleki).

3. KAU NGAUE MO E VAHENGA

'I hono fakakalakalasi 'o e kau ngaue ('i he 3.1 (a ki he h)) kataki: -

- i) Hanga 'o fakafonu ange 'i he kolomu 2, 5 mo e 8 'a e tokolahi fakakatoa e kau ngaue he mahina takitaha 'o e kulupu takitaha 'o e kau ngaue 'o fakatatau ki hono fakakalakalasi 'oku ha atu.
- ii) Fakafonu ange he kolomu 3, 6 mo e 9 'a e fakakatoa e pa'anga vahenga ne 'oange ki he kulupu takitaha 'o e kau ngaue lolotonga e mahina takitaha 'o e kuata.

3.1 Kulupu 'o e kau ngaue: -

- a) Tokotaha 'oku 'o'ona e ngaue'ang: 'oku 'uhinga 'eni ki he tokotaha 'oku 'o'ona e ngaue'anga pea ne toe ngaue foki ki hono ngaohi e koloa.
- e) Kau ngaue 'oku nau ngaohi e koloa: 'oku 'uhinga eni ki he kau ngaue 'oku nau tautonu ki hono ngaohi e koloa ko ia 'i he ngaue'anga, hange ko e kau ngaue tu'upau/fakataimi/lau'aho (kau ta'oma, kau ta piliki etc.)
- f) Memipa 'o e famili 'oku ngaue 'o 'ikai ha vahenga: 'oku 'uhinga 'eni ki ha memipa 'o e famili 'oku ngaue 'i he ngaue'anga 'o 'ikai ha totongi tu'upau 'o 'ikai toe si'i hifo 'i he vahetolu 'e taha 'o e houa ngaue tu'upau.
- h) Toenga 'o e kau ngaue: 'oku 'uhinga 'eni ki he kau ngaue 'oku 'ikai ke nau kau 'i he fa'ahinga 'o e kau ngaue 'oku ha atu 'i 'olunga, ki hono ngaohi 'o e koloa, (hange ko e kalake, tauhitohi, le'o, faka'uli, faitaipe etc.) ka 'oku nau kau he ma'u vahenga he ngaue'anga.
- 3.2 Ngaahi koloa 'oku foaki 'ikai ha totongi: 'oku 'uhinga 'eni ki hono fakamahu'inga'i ki he tokotaha 'oku 'a'ana 'a e ngaue'anga 'a e ngaahi koloa pe ko e ngaahi 'aonga 'o e ngaue'anga ki he kau ngaue 'o 'ikai ha totongi pe ko e totongi 'oku ma'ulalo ange 'i he totongi totonu (lau ki ai 'a e me'atokoni, inu, tapaka mo e vala).
