The Tonga Statistics Department (TSD) now invites **eligible individuals (“Consultants”)** to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services (attach curriculum vitae with description of experience in similar assignments, similar conditions, etc.)

. The criteria for selecting the Consultant are:

- At least Master’s degree or PhD in economics, statistics or other related field
- At least Six years of professional experience for a Master’s degree holder or Two years’ professional experience for a PhD holder in similar assignments

- Advanced Experience in the production of economic statistics and price indices;
- Experience with planning, implementing, and managing a national household survey;
- Experience with microdata analysis using statistical software (STATA or R);
- Experience with Household Income and Expenditure Surveys is desirable;
- Experience with Computer-Assisted Personal Interviewing (CAPI), and particularly the Survey Solutions software, is desirable;
- Excellent verbal and written communication skills in English;
- Strong management skills in a diverse (cultural and technical) work environment;
- Experience working with development partners such as WB, ADB, DFAT would be an advantage.

Scoring: CVs of eligible candidates that meet the minimum requirements will be scored according to the following criteria:

1) General qualifications (general education, training, and experience):	20
2) Adequacy for the Assignment (relevant education, training, experience in the sector/similar assignments)	65
3) Management skills in a diverse (cultural and technical) work environment and Experience working with development partners such as WB, ADB, DFAT	15
